London (task was to improve the fit between research and practice). 1971-73: *London*: project leader, and subsequently section head in the operational research dept. at the central computing centre, for development of OR models, a.o. for scheduling, personnel planning, design of loading facilities. The main project was an interactive simulation model for Shell group strategic planning for the board of directors (in 1972-73 contingency plans were made in anticipation of the oil crisis). Participated in the development of the Shell approach of *scenario planning*.
